ORDER

1. The Principals of following affiliated institutions of KUHS were applied for QAS Accreditation in response to the notification read (1) above. Accordingly, University conducted inspections at the institutions for assessment of quality assurance standards. The Quality Assurance Monitoring Committee of the University, after detailed examination and evaluation of the inspection reports, recommended the following grades to the institutions.

2. After completing three years of KUHS-QAS accreditation, Bishop Benziger College of Nursing, Kollam had applied for re-accreditation as per the paper read (2) above. Based on the completion of QAS reaccreditation visit and Quality Assurance Monitoring Committee Meeting decisions the institution was eligible for A+ Grade.
